Addendum 3

The following addendum supersedes previous information and does hereby become part of the contract documents:

- This project is being rebid with a reduced scope of work. The new bid date is April 16, 2024 at 2:00pm. A 100% performance and payment bond will be required for this project. A bid bond will not be required. A prebid conference will be held at the Town Hall at 2:00pm April 9, 2024.
- The new base bid scope of work to be bid is described as follows:
 - Pre-Engineered metal building (delete window W-1). Revise roof to 26 gauge R panel galvalume.
 - o Provide R-35 simple saver roof insulation and R-19 simple saver wall insulation.
 - Build slab including rear concrete apron at door 100H and concrete stoops at personal doors.
 - o Building pad
 - o Rough Grading to a point 5'-0" outside of building perimeter.
 - Front apron delete pervious pavers and provide 6" 4,000psi concrete apron with 6x6W4.0 wwf. (Portion in front of door 100H to be 8")
 - Bollards as per previous BD-1.
 - Base Bid: Reduce shop area building slab to be 6" with 6x6W4.0 wwf except bay at door 100C which will be 8" thick 4,000psi concrete with 6x6W4.0 wwf. This also includes concrete apron at door 100H.
 - Base Bid: Delete requirement for field painting of PEMB structure.
 - All site clearing will be by Owner.
 - Removal of existing septic field will be by Owner.
 - Delete all electrical and gas items. PEMB to include in base bid framing for future exhaust fan shown in M-1.
 - Base Bid: Delete hoist beam.
 - o Base Bid: Knox box and building address to be provided by Owner.
 - Base Bid: Owner will remove existing light pole and water spigots within building perimeter.
 - o Base Bid: Delete Mechanical and Electrical requirements for the building.
 - o Base Bid: Specifications; 01020:
 - o Reduce contingency allowance to \$10,000.00.
